NOTIFICATION

The first meeting of Board of Management (BoM) was held on 20th June, 2007. Following decisions were taken in that meeting :

Affiliation Fees:

S.No.	Name of Faculty	Affiliation Fees per year	Penalty
1.	Every undergraduate course of Engineering & Architecture	Rs. 50,000/- for first branch & Rs. 25,000/- for every subsequent branch	1. The affiliation fees will be accepted upto 31-08-2007 without penalty (for the years 2006-07 & 2007-08 both) 2. Penalty will be equal to the amount of affiliation fees from 1 st Sept. 2007 to 31.12.07
2.	MBA, Hotel Management & Catering Technology, etc.	Rs. 50,000/- for each Program	3. Penalty will be the double amount of affiliation fees from 1 st Jan. 2008 to 31.3.08
3.	MCA	Rs. 50,000/-	4. After 31.3.2008 enhanced penalty will be recovered to be decided later on.
4.	For every Post Graduate course in Engineering	Rs. 25,000/- per Specialization	

Note:

1. If any College has deposited affiliation fees in RTU earlier, that amount will be adjusted.
2. If any College/Institute deposited affiliation fees in University of Rajasthan, Jaipur or any other University in Rajasthan, such College/Institute will have to deposit the above mentioned affiliation fees in Rajasthan Technical University, Kota for the session of 2006-07 and 2007-08. The amount already deposited in University of Rajasthan or other University will be adjusted after receiving affiliation fees from the concerned University to RTU, Kota in the subsequent years.
3. After Academic session 2007-08, the above affiliation fees structure shall remain same unless further revised by RTU, however; the last date for depositing affiliation fee shall be 31st Dec. of each year. Penalty equal to the amount of affiliation fees shall be charged from 1st Jan to 30th April & penalty double the amount of Affiliation fees shall be charged if fees is deposited from 1st May to 7th July. After this date enhanced penalty shall be charged to be decided later on.
4. As stated by the Notification of Govt. of Rajasthan No. F.23(2)TE/2006, the affiliation of any institute with effect from 1.7.2006 shall be given by R.T.U. So, any affiliation done by University of Rajasthan or any other University after 30.6.06 is not acceptable. Similarly any permanent affiliation obtained from any University is also not acceptable and in all such cases the affiliation has to be obtained from R.T.U., Kota

Endowment Fee

Endowment Fee will be Rs. 5,00,000/- in the form of Bank Guarantee from a nationalized Bank from each private College for a period of 5 years.

The above guidelines will come into force with immediate effect. This Notification bears the approval of Hon'ble Vice Chancellor.
