BOM Meeting started with the opening remarks by the Hon'ble Vice Chancellor on various activities carried out by the University in recent times;

- i. University has successfully conducted all semester examinations as per schedule and declared all the results in time.
- ii. Inspection of colleges for affiliation was carried out in a time bound programme and completed this activity in a time frame.
- iii. University completed centralized admissions of students in various M.Tech. programme of the colleges in time.
- iv. Research centres were inspected and these were recognized by the University to promote research activity.

Hon'ble Vice Chancellor further informed the members about issues considered in Vice Chancellor Coordination Committee and directions of Her Excellency;

- i. H.E. directed to fill all vacant posts of teaching and non-teaching staff.
- ii. H.E. directed to implement UGC guidelines and norms in the University.
- iii. H.E. desired that the Universities must strive to seek maximum grant from UGC and Central agencies.
- iv. The matter of funds for pay and pension was also raised by Vice Chancellors. The Chief Secretary asked the Vice Chancellors to forward complete information with regard to their universities on the total liability on this account till the last person appointed prior to the adoption of Contributory Pension Scheme in 2004 superannuates. H.E. directed the officials to look into the same.
- v. The Chief Secretary, Government of Rajasthan, underlined the importance of achieving academic excellence, administrative independence and financial autonomy for the state universities. In particular, the need to ensure the performance and quality of the teaching and research functions of the universities was

emphasized and the universities were requested to monitor this closely using available technology such as biometric attendance marking etc. where feasible.

- vi. H.E. also highlighted the need to cut down the non-teaching staff substantially by introducing technological innovations in the functioning of the universities.

Development fee was made applicable after the resolution of BoM vide its resolution item No.1.10 with the recommendation that the fee will also be charged from the students in their subsequent academic years as mentioned in the office order issued by the Registrar dt 10.10.2007 (Annexure-15.8.2 pages 137-139). The development fee was in existence even before the above



resolution of the University however the same was collected at the time of admission by the coordinator RPETEAP only from the fee of the college on the basis of total students admitted in I B.Tech., whereas University decided to charge the same as indicated in the table in the order of the Registrar dated 10/10/2007. The anomaly which was brought to the notice of the University that whether the order is effective from the academic year 2006-7 or 2007-8 was clarified by subsequent order of the Registrar dated 31/1/2009. However still some colleges are refusing to deposit the old dues and some dues are pending from other colleges in recent times. The details about the pending dues are indicated in the enclosure (Annexure-15.8.3 pages 140 to 146)

The above pendency has resulted in to the audit para which may convert into draft para and therefore university is constrained to initiate all necessary measures in realising the dues. Notices have been issued and colleges are rigorously being perused to deposit pending dues but in vain. It is therefore

proposed to consider following proposal so that recovery efforts become effective;

1. BoM may consider ratification of the office order issued by the Registrar dated 31/1/2009 (Annexure 15.8.1 page- 136)

2. Furthermore, BOI may be authorized to initiate all possible measures such as legal/Penal/Criminal proceedings, including reduction in intakes/withholding results or any other action deemed fit against the defaulting colleges as per the advice of University advocate.

To consider teaching in departments wherein laboratories are yet to be established or expertise is not available during infancy period by inviting experts or by taking students to other Institutions / organizations.

University is trying to create human resources in area where our state needs professional to cope up with increasing opportunity in many emerging areas. However in many such cases the development of laboratories and availability of expert human resource may take some time. The conduct of laboratories and theory classes, wherever such necessity arises, shall be managed by inviting expert faculty or by taking students to institutes who agree for conduct of laboratory/theory classes.

Under the above mentioned circumstances it is proposed that;

- i. Such activities may be permitted on mutually agreeable terms and conditions of the University and government institutions like IIT/IIIT/IIM/NIT/ State Universities/

Government Colleges/Research laboratories  
etc.

ii. The travel expenditure of students may be supported limiting it to sleeper class (with train concession, wherever applicable). RTU support for lodging and boarding for the students may be provided in line with the permission granted to UG students of Petroleum Engineering Branch (Annexure 15.9.1 Pages 147 to 148) which has been already approved by BoM.

iii. The travel expenses to experts may be permitted by Air (economy class) as per TA rules of the RTU approved by State Govt. to the nearest airport so that the best of the faculty from premier institutes of the country can be invited for guidance and development of such areas in the University.

To consider hiring of services for clearance from Custom and forwarding imported lab equipments from International airports to RTU, Kota

Many laboratory equipments required need to be imported in the current financial year and next 2-3 years in the new laboratories in UG/PG programmes and also under TEQIP project. The bidders have quoted/quote rates up to International airports in India with condition of arranging custom clearance and transporting the equipment by RTU from the Delhi/Mumbai any other such destinations.

IITs and other educational organisations importing equipments as a routine matter with hiring of services of agencies/personnel acquainted with the custom and international practices. Delay in custom clearance or by any reason in lifting the imported material from the airports invites heavy penalty in the form of Demurrages charges to the importer.



To facilitate procurement of the lab equipment in time, hiring of services of such personnel, which may be renewed on yearly basis by the University for different International Airport Stations, such as Delhi, Mumbai, etc. transportation has also to be arranged by the service provider in such cases. Hiring may be permitted through inviting expression of interest through open advertisement and rates thereof; then empanelment of the suitable agencies/persons. Rates for the transportation may be approved on yearly basis for different airport stations periodically.

RTU has been trying to construct its buildings like hostel/academic blocks through state Govt agencies, such as PWD, RSRDC etc. However, RSRDC is taking a lot of time in construction of buildings of the University and recently RSRDC could not start work in spite of advance payment of Rs. 1.5 crore for almost one year. The state government has already been informed about these facts. In the light of above and more so when audit has raised a para in this connection, it is proposed to engage CPWD for construction of some of the buildings in the University campus due to urgent demand for the same.

MOU as received from CPWD is enclosed for kind perusal of Hon'ble members (Annexure-15.11.1 pages-149 to 151).

Presently total no. of connections operating in the campus are 241 (copy of latest bill by BSNL enclosed at Annexure-R15.1.2 pages 169 to 174). In addition, 20 VPN connections are also established under MHRD scheme "NME-ICT".

In compliance of BoM resolution the excess expenditure more than the ceiling limit is being recovered from the connections provided at the residence of officials however the ceiling limit of



offices which are in lieu of office work of RTU only are waived off.
