PREFACE

Rajasthan Technical University is engaged in teaching, research and specialized program of technical studies aimed to disseminate, create, preserve and generate the knowledge in the field of technical education for the advancement of country and mankind. It also grants affiliation to the colleges and institutions which are running courses such as Ph.D., M.Tech., B.Tech, MBA, MCA, B.Arch, BHMCT

located in Rajasthan in accordance with provision laid down in RTU act 2006. The university has its constituent college namely UCE Kota located in its premises and eight Govt. engineering colleges i.e. Ajmer(2), Bharatpur, Bhilwara, Bikaner(2), Jhlawar, Banswara are also affiliated to the University.

The Rajasthan Technical University conducts examinations for courses being run by the affiliated colleges/constituent college twice in a year on semester basis. The University college of Engineering, Kota has hostel facility for both male & female students separately along with a central library. It also has separate laboratories for each departments of engineering and common facilities such as health centre, shopping centre, placement cell, sports office, chief proctor, guest house and conference hall etc.

#### **INCOME & EXPENDITURE:**

The technical university is one of the largest universities of state having more than 3 lacs students enrolled with it. It is dependent for funding on the State Govt. which is being given on an adhoc basis to meet out the funding gap as per norms prescribed by the State Govt. The State Govt. has allotted Rs 200 lacs under plan head and nominal grant under non-plan head for the year 2012-13 but in RE for 2012-13 in Plan & Non Plan head Token Grant Rs 0.01 lacs has been sanctioned. Therefore in the Budget Estimate in 2013-14 under Plan & Non Plan only Token Grant Rs 0.01 lacs has been proposed.

On approval by Finance Committee & BOM, the university utilizes its own income for establishment and development purposes and on the items given below;

- i. On conducting examination (including recurring and non-recurring)
  - ii. For construction of new buildings
- iii. Payment of Salary, Transportation of staff and guests.
- iv. Students' activities & sports etc.
- v. Procurement of lab equipments.
- vi. Acquisition of books & journals.
- vii. Purchase of furniture, equipments, machinery, software & other office aids.
- viii. Contractual services such as Security Service,
  Cleaning, Hiring of Vehicles, AMC and hiring of
  data entry operator (Machine with man)

The university is making every effort to effect necessary curtailment in the expenditure under various heads by adopting economy measures related to financial economy as per instruction of State Govt./MOU executed thereof.

For better fund management, the university has generated an interest income of Rs. 665.42 lacs up to 31.12.2012 with revised estimate of Rs 912.90 lacs for 2012-13 with estimated income of Rs 840.20 lacs for 2013-14 looking to interest rate scenario as well as availability of unspent fund.

### **PENSION**

The University has adopted the new pension scheme w.e.f., 1-1-2004 as applicable to the State Government employees appointed on or after 1-1-2004. The contribution of the employees and employer share deposited in PF account has been transferred to the pension fund as per rules and regulation prescribed by the State Govt. Registration of the institution has been done by NSDL and PRAN No. have been allotted to the employees.

### STAFF WELFARE ACTIVITIES

The University has created a corpus fund for providing financial assistance/support to the poor/needy members of staff of the university. Certain percentage of remuneration to be given to the examiners/evaluators of answer books contributes towards this fund. The rules for management of this fund have been framed and also approved by the BOM and process of execution of trust Deed is under pipe line.

### MEDICLAIM POLICY

Scheme of Medi-claim policy has been adopted by the University from F.Y. 2013-14 at par that of undertaken by the State Govt.

However, expenditure to the tune of Rs. 3544.87 lacs was incurred during F.Y 2011-12 while budget estimates for the F.Y 2012-13 has been projected to the tune of Rs. 6104.40 which is more than Rs. 25.60 crores. This projection is based on periodical increase in salary, allowances & enhanced rate of remuneration/honorarium charges towards exam related work, proposed construction-renovation work of buildings in II phase and transfer of Rs 10 crores funds to 5 Government Colleges.

### RENT FROM SHOPS/COMMERCIAL AGENCIES

The university realized the rent from shops, guest house, hostels etc. to the tune of Rs. 44.57 lacs for F.Y 2012-13.

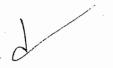

#### EXPENDITURE

Provision of Rs. 150 lacs in RE 2012-13 & in BE 2013-14 200 lacs for construction of laboratories in the departments and girls hostel has been kept.

Provision of Rs. 500 lacs in BE 2013-14 & 150 lacs in RE 2012-13 for construction/renovation of various building under own income head.

Provision of Rs. 70 lacs in RE 2012-13 & Rs 290 lacs in BE 2013-14 for procurement of machinery and equipment/IT infrastructure, computer hardware & software in UCE.

Provision of Rs. 79 lacs for automation, e-resource & purchase of library books in RE 2012-13 & Rs 80 lacs in BE 2013-14.

Provision of Rs 1.00 crore has been taken for B.E. 2013-14 for computerization of Accounting & financial system (based on double entry) of the University.

Head of the office wise expenditure proposed in the University for RE 2012-2013 and for BE 2013-14 in detail is attached at an Annexure 16.6.2 page No.68 to 77.

- 3. The reconciliation of various accounts need to be made in time so that cash book figures reflect correctly the position of the funds of University. Efforts may be made to transfer funds to appropriate heads.
- 4. The variation in figures may be presented in various heads appropriately where ever necessary.

University vide BoM agenda No.1.4 has adopted the statute of the University of Rajasthan. The statute of the UOR provides qualification and Composition of selection Committees for the various posts. However the provision for Security officer is not available in the list of UOR. All the employees are presently governed as per prevailing service rules of the UOR/RSR.

The Post of the Security officer has been sanctioned in the Pay-band of Rs.9300-34800 and Grade Pay Rs.3200 which is equivalent to the post of Stenographer. The posts of security officer shall be as isolated through 100% direct recruitment.

University has inherited the cadre of Laboratory Assistant (LA) from the erstwhile Engineering College Kota. The Cadre of LA does not have appropriate well defined ladder for promotion neither in the Ministerial cadre nor in the Technical cadre. Previously the Board has resolved vide agenda No.6.8 to consider the promotion of LA in Ministerial cadre (Annexure-16.8.1 page No.79 to 85) by 8% in addition to 15% from Peon. However, the same could not be implemented due to maximum ceiling of 15% from peon to LDC as per the state government rules.

Medical Education Department of Government of Rajasthan has a provision for promotion of Literate Attendant and Laboratory Attendant to the post of Technician, if he/she fulfils the prescribed qualification, to the extent of 15% posts of the Laboratory Technician.

It is therefore proposed to consider a similar proposal for the Laboratory Attendant of the University to Technician to the extent of 15% as no post with the designation of literate attendant exists in the University.

Currently B Tech programme in Petroleum Engineering is running in the constituent college of the University. For this State Govt has sanctioned eleven teaching positions with 2 Professors, 2 Associate Professors and 7 Assistant Professors.

The course curriculum involves teaching of some subjects related with Geophysics like Basic Geophysics, Prospecting (Seismic), Well logging etc. A teacher qualified in the specialized areas of Geophysics can teach such subjects. Similarly, Petroleum Geology is a core subject for the B. Tech., course. A person qualified in the specialized area of Geology may teach such subjects in a better way.

Rajasthan Technical University has about 300 different affiliated institutions and with the dedicated faculty and students of these institutions it is continuously making efforts to make inroads in the novel research area and even try to get patents. At present there is a gap between the knowledge acquired by an engineering student during his/ her education and the need of the industry. 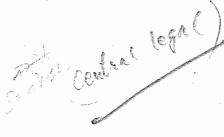
Many innovative steps were taken to steer the country from extreme backwardness establishment by laboratories, IITs, IISc., RECs', ISRO, BARC to name the few.
