BOM. T.17.1(Spl)

To consider the proposal for transfer of students, change of branch within the jurisdiction of Rajasthan Technical University.

During the Special BOM Meeting the Principal Secretary, Technical Education with the permission of the Chair raised the issue of several students approaching the University and the Government for transfer from one college to another college in the jurisdiction of Rajasthan Technical University. Members suggested that it would be appropriate if the matter is dealt by the university rather than referring the matter to the state government in special cases also. The Members unanimously expressed the opinion to constitute a committee in the University to examine the possibility of mobility of students within the affiliated colleges of the university.

Similarly, the issue of change of branch may also be dealt by the University adopting flexibility. If the seats are remaining vacant and no-objection is provided by the colleges the change of branch rules may also reviewed by the above committee.

Resolution

The BOM Members appreciated the concern shown by the Principal Secretary, Technical Education and suggested that a committee shall be constituted by the HVC to examine the above proposal. The committee should submit its report at the earliest to the H.V.C. which may be put up for consideration in the next BOM.

BOM. T.17.2(Spl) To consider digital evaluation of answer books in the term end examination of the University.

During the special BOM meeting the matter of digital evaluation of answer books was raised by the Principal Secretary, Technical Education with the permission of the Chairman as under.

Presently University's examination answer books are examined manually in traditional form by examiners. The process has few weakness and results into some errors in the entire process. It is therefore proposed to introduce digital evaluation of answer books so that entire process of evaluation become fast, error free and access of information process become simplified, under examination of copies by students.

Member appreciated the innovative concept of evaluation & suggested that University may examine the possibility of implementing digital evaluation at the earliest.

Resolution

It was resolved that University team may visit one of the university is South India having similar evaluation system and thereafter the digital evaluation concept may be adopted by the University.
