Please refer to the Public notice issued by AICTE for approval process (copy enclosed) declaring 03rd April, 2021 as the last date for the submission of application, as per the case mentioned in APH 2021-22 by existing technical institutions for session 2021-22.

For setting up of new technical institute, it is mandatory to obtain a stamped receipt with official seal from the Dean, Academic Affairs of the Rajasthan Technical University as proof of submission of Detailed Project Report (DPR). The institute has to deposit fees as per affiliation fee rules displayed on RTU website (**Refer to Office Order RTU/F(3)/Acctt./132/14th FC/2015-16/1510-35, dated 21.07.2015 and any other such orders available on University's website**).

Further, the existing institutes seeking required NOCs, as per the requirement of AICTE APH 2021-22 from the University for the following cases, are advised to submit the applications along with all supporting documents and requisite fees, as per the guidelines enclosed latest by **30th April, 2021** :
