Tech. 2006 to 2011, LEEP 2007 to 2012, BHMCT 2006 to 2011, B. Arch. 2006 to 2009, BBA 2013, MCA 2006 to 2013, MBA 2006 to 2015, M. Tech. 2006 to 2015 and M. Arch. 2006 to 2015 admitted batches. Such students shall be allowed for 'Additional Mercy Chance' attempt for the session 2020-21 examinations.

Schedule for filling up of online examinations forms etc. of the Additional Mercy Chance will be notified on RTU website separately and same information will also be provided to affiliated colleges.

The concern students are required to be in touch with their respective colleges/RTU website for schedule of filling up of online examination forms etc. The affiliated colleges are also required to contact such all concerned students and prepare a database of students. College should ensure at their level that examination forms of all such students will be submitted to the University as per schedule.

In case of any lapse on the part of college/institution/student, the concerned college/institution/student shall be responsible for the same.

This chance shall be last and final chance, so before filling up of examination form(s) in all backlog paper(s), it is strictly advised that they may ensure their final backlogs before filling up of mercy back examination form(s). Further, candidate may also ensure that their internal/midterm marks in backlog papers are sufficient, if not then they should apply and appear in improvement exam of such papers alongwith End Term Exam/External Exam. OFFICE-ORDER

Board of Management vide its resolution no. 39.17 held on 26.07.2021 granted an "Additional Mercy Chance' to students admitted in B.Tech 2006 to 2011, LEEP 2007 to 2012, BHMCT 2006 to 2011, B.Arch. 2006 to 2009, BBA 2013, MCA 2006 to 2008, MBA 2006 to 2015, M.Tech. 2006 to 2015 and M.Arch. 2006 to 2015 in the session 2020-21. Academic Council vide agenda no 33.1(s) in its 33rd meeting and subsequent approval of Board of Management vide agenda no. resolution no. 40.4 in its 40th meeting and again by Academic Council vide agenda no. 35.10 in its 35th meeting, allowed promotion including promotion rules for above eligible batches students for intermediate semester and examination in online/offline mode for final semesters of all PG and UG courses.

Promotion rules are decided as per following:

A. Eligible Examinees:

- (a) Back Examinees of B.Tech & BHMCT Courses I,II,III,IV,V,VI, & VII Semester
- (b) Back Examinees of B.Arch. Courses I, II, III, IV, V, VI, VII, & IX Semester
- (c) Back Examinees of BBA Courses I, II, III, IV, V Semester
- (d) Back Examinees of M.Tech. (Full Time), MBA and M.Arch Courses I, II, III Semester
- (e) Back Examines of MCA I, II, III, IV and V Semester

of above mentioned batches, who are eligible to appear in above mentioned semesters examinations of session 2020-21

B. Promotion rules for above Eligible Examinees:

End-Term (Theory) and Practical (External):

- (i) For B.Tech. and B.Arch. course: Minimum passing marks (as prescribed in applicable scheme) in the concerned failed End Term Theory Subject/Practical (External) subject shall be awarded. Subjectwise total marks shall be calculated as a total of minimum passing marks (as per above) and mid term/internal/sessional marks.
- (ii) For BBA, BHMCT, MBA, MCA, M.Tech. & M.Arch. course: Minimum passing marks (as prescribed in applicable scheme) in the concerned failed End Term Theory Subject/Practical (External) subject or carry forwarded marks, whichever is higher, shall be awarded. Subjectwise total marks shall be calculated as a total of minimum passing marks/carry forwarded marks (as per above) and Mid term/Internal/Sessional marks.

Mid-Term and Practical (Sessional):

(i) Wherein minimum passing marks are prescribed for Mid Term and Practical (Sessional) component, the minimum passing marks or carry forwarded marks of same subject whichever is

(ii) Wherein minimum passing marks are not prescribed for Mid Term and Practical (Sessional), the previous Mid-Term and Sessional (practical) marks of same subject shall be carry forwarded, if he/she did not opt for improvement in previous performance.

(iii) If he/she has opted for improvement in previous performance, then his/her present actual obtained marks after improvement, shall be considered as final.

Subject wise total shall be counted after addition of both components (End Term/Practical and MidTerm/Sessional) and result will be prepared accordingly as per prescribed scheme.

In addition to above, following are also decided :-

These promotion rules shall be applicable to only those students who are declared eligible to (a) appear in odd/even semesters's examinations of session 2020-21 under the provisions of applicable rules. Provided, he/she has filled the relevant semester examination form(s) as per rules alongwith requisite exam. fee and whose exam form(s) were submitted by the concerned college through online portal of RTU within the given schedule. Lapses in any of above shall not permit for promotion.

If any of student who was debarred or punished under any of the Provisions/Regulations of (b) the RTU and his punishment was effective upto session 2019-20, shall compulsorily be required to appear in ensuing examinations (whenever held) as per the decision of RTU and

he/she shall not be considered for promotion.

If any of the student who was transferred from any of the other University as per due (c) permission of Dean, AA Office, he/she shall compulsorily be required to appear in ensuing examination(s) for those subjects which were decided as non-equivanlance subjects and he/she did not clear these subjects yet, shall not be considered for promotion.

Results calculated as per above formula will be declared and shown in the mark sheets as (d) per the prevailing scheme after conversion of marks in normal scheme.

If any student wishes to improve the grades or he/ she is not satisfied with the results of (e) Intermediate Semester(s) calculated on the basis of above formula, he/she may appear in all subjects of concerned semester examination (only once) in physical examination as per schedule declare by the University.

The marks obtained by the candidate in the examination (as per point 'e') shall be treated as (f)

final for those who have opted to take these examinations.

Final Semester Examination of these eligible batches examinees (as per para 1 of this order) of all UG and PG courses will be conducted and schedule will be declared shortly in online /offline mode as per suitability of the University
